DE-ANNEXATION OF CERTAIN PROPERTY  
IN THE COPORATE LIMITS OF THE  
CITY OF SCOTTSBORO, ALABAMA

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SCOTTSBORO, ALABAMA, as follows:

1. That the City Council of the City of Scottsboro, Alabama, hereby assents to the de-annexation of certain property and territory to the City of Scottsboro, Alabama, which property or territory is more particularly described as follows:

The tract is described as a tract or parcel of land located at the South half of the Southwest Quarter of Section 29, Township 5, Range 5 East in Jackson County, Alabama which is East of Alabama Highway #79, West of Guntersville Lake, and North of the Southerly Section line of said Section 29. *SEE EXHIBIT 'A' FOR A MORE SPECIFIC DESCRIPTION*

2. That the corporate limits of the City of Scottsboro, Alabama, be and hereby are amended to exclude the hereinabove described property as a part of the corporate area of the City of Scottsboro, Alabama.
  
3. That this Ordinance shall become effective upon its publication or posting as required by law.

**"SECTION 5311 RURAL AREA PUBLIC TRANSPORTATION"**

WHEREAS, the **City of Scottsboro** recognizes the need for a public transportation program; and

WHEREAS, the **City of Scottsboro** is recognized as a member of the **(Any County)** Transportation Steering Committee; and

WHEREAS, the **City of Scottsboro** recognizes that the requirements to obtain Section 5311 funds from the Alabama Department of Transportation include a local match of 50% for operating expenses and 20% for administration, planning, and capital expenses; and

WHEREAS, the **City of Scottsboro** recognizes that the local match will be a shared cost with other participating municipalities being responsible for providing an appropriate allocation of local non-federal funds to secure the operating of the Section 5311 Rural Area Public Transportation Program.

NOW, THEREFORE, BE IT RESOLVED, that the **City of Scottsboro** hereby commits

the amount of **\$44,405** as local non-federal match for operations, administration, planning, and capital expenditures under the Section 5311 Rural Area Public Transportation Program during Fiscal Year 2019.
