

**MINUTES OF THE
SCOTTSBORO CITY COUNCIL
SEPTEMBER 4, 2018**

The City Council of the City of Scottsboro, Alabama met in a Special Called Meeting on September 4, 2018 at 11:13 a.m. in the Gail J. Duffey Auditorium of the Scottsboro City Hall.

The meeting was called to order by Council President Tony Wallingsford. Invocation was given by Council President Wallingsford. Pledge of Allegiance was led by Council Member Patrick Stewart. The roll was called by the City Clerk Whitney Phillips with the following results:
