The City Council of the City of Scottsboro, Alabama met on October 26, 2020 at 6:00 p.m. in the Gail J. Duffey Auditorium of the Scottsboro City Hall.

RESOLUTION 2020-10-39

WHEREAS, The City of Scottsboro, Alabama’s Recreation Department is in need of a vehicle, and.

WHEREAS, Section 41-16-50 through 41-16-63, Code of Alabama 1975 authorizes the municipal governing body to secure sealed bids; and

WHEREAS, Section 11-45-2(c) of the Alabama Code of 1975 authorizes the municipal governing body to accept bids by the adoption of a resolution;

NOW, THEREFORE, BE IT RESOLVED by the City Council of Scottsboro, Alabama as follows:

Section 1. That the City of Scottsboro posted one (1) bid, mailed six (6) bids by US Postal Service, and received one (1) bid for the 2021 SUV Vehicle.

Section 2. It is recommended by the Bid Review Committee that the bid be awarded to High Country Toyota as only responsible bidder that met specifications.
