The City Council of the City of Scottsboro, Alabama met on February 28, 2022 at 5:00 p.m. in the Gail J. Duffey Auditorium of the Scottsboro City Hall.

The meeting was called to order by Council President Richard Bailey. Invocation was given by Mayor Jim McCamy. The Pledge of Allegiance was led by Council Member Mike Ashburn. The roll was called by the City Clerk Whitney Phillips with the following results:

**CONSIDER BUDGET AMENDMENT FOR BATTERIES FOR  
WEATHER SIREN**

Council President Richard Bailey called for a motion to approve a budget amendment for \$985 from excess sales tax to purchase batteries for a weather siren. Motion was made by Council Member Mike Ashburn and seconded by Council Member Ralph Dawe. No discussion. Upon a vote being taken all members voted aye.

**CONSIDER BUDGET AMENDMENT FOR ADDITIONAL  
TRUCK FOR THE BUILDING INSPECTION DEPARTMENT**

Council President Richard Bailey called for a motion to approve a budget amendment for up to \$35,000 from excess sales tax for an additional truck for the Building Inspection Department. Motion was made by Council Member Ralph Dawe and seconded by Council Member Nita Tolliver. No discussion. Upon a vote being taken all members voted aye.

## **ANNOUNCE LIBRARY BOARD APPOINTMENT**

Council President Richard Bailey called for a motion to appoint Cynthia Patridge to the Library Board. Motion was made by Council Nita Tolliver and seconded by Council Member Gary Stewart. No discussion. Upon a vote being taken all members voted aye.

## **CONSIDER AIRPORT DIRECTOR APPOINTMENT**

Mayor Jim McCamy recommended that J.B. Sandlin be appointed as the permanent Airport Director. He has been serving as interim director since July 2021. Motion was made by Council Member Mike Ashburn and seconded by Council Member Gary Stewart. No discussion. Upon a vote being taken all members voted aye.
