RESOLUTION 2023-03-19

WHEREAS, The City of Scottsboro's Sanitation Department is in need of a baler repair and;

WHEREAS, Section 41-16-50 through 41-16-63, Code of Alabama 1975 authorizes the municipal governing body to secure sealed bids; and

WHEREAS, Section 11-45-2(c) of the Alabama Code of 1975 authorizes the municipal governing body to accept bids by the adoption of a resolution;

NOW, THEREFORE, BE IT RESOLVED by the City Council of Scottsboro, Alabama as follows:

Section 1. That the City of Scottsboro posted one (1) bid, mailed four (4) bids, and received zero (0) bids for the baler repair.

Section 2. It is recommended by the Bid Review Committee that the City Council authorize Solid Waste Director Stacy Ledwell to negotiate bids for the baler repair.
